AMENDATORY ORDER

BY THE COMMISSION:

On February 24, 1998, Order No. PSC-98-0326-FOF-GU, was issued in Docket No. 971618-GU. The Order granted Tampa Electric Company d/b/a Peoples Gas System (Peoples) modifications to its experimental weather normalization adjustment rider.

The above referenced order mistakenly referenced the month of "October", instead of "November," in the phrase "October 1998 through April 1999." Page 2, paragraph 5 should read: "During the first period of the pilot program (November 1996 through April 1997)" Page 3, paragraph 1, should read: "For the period November 1997, through April 1998," And, finally, Page 3, paragraph 1, line 6, should read: "For the final period of the experiment (November 1998 through April 1999)"

The last sentence of the first paragraph, on page 3 mistakenly referenced "FPL" instead of "Peoples." This order is hereby amended to read as follows: "We find that these proposed tariff revisions are in the best interest of Peoples and its ratepayers."

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-98-0326-FOF-GU is amended as discussed in the body of this Amendatory Order. It is further

ORDERED that Order No. PSC-98-0326-FOF-GU is affirmed in every other respect.


