Pursuant to Florida Administrative Code Rule 25-22.006(3)(a), Florida Power & Light Company ("FP&L") files this Notice of Intent to Request Confidential Classification. Since it is unclear to FPL whether its prior request (pursuant to Rule 25-22.006(3)(a)2.) that information provided to auditors be kept confidential would extend to FPL's audit response, this Notice of Intent relates to FPL's response to the "FPL and FPL Services Cost Allocation Audit Report," Audit Control No. 97-233-4-1. FP&L is filing its response to "FPL and FPL Services Cost Allocation Audit Report," contemporaneously with the filing of this Notice. FP&L, pursuant to Rule 25-22.006(3)(a), F.A.C., requests confidential handling of FPL's entire response until FPL can file a Request for Confidential Classification addressing the specific portions of the audit response which are confidential.
