COMES NOW BellSouth Telecommunications, Inc. ("BellSouth"), and hereby files, pursuant to the Florida Administrative Code, its Motion to File Request For Confidential Classification One Day Out of Time, and states the following:

1. On February 16, 1998, an audit exit conference report was issued in the above captioned docket for Staff's Audit of BellSouth Loop & Port Combinations, Audit Control No. 98-0123-4-1. Staff has identified certain documents and information that it desires to include in its audit workpapers to support its audit in this docket.
