Thank you for your letter in which you protest the notice of application for extension of service area of Rainbow Springs Utilities, L.C. On December 16, 1997, this Commission received the application of the utility for amendment of Certificates Nos. 355-W and 311-S to include additional territory in Marion County. The application was reviewed and found to be deficient because it did not provide the affidavit for newspaper publication. Also, there was a problem with the legal description in the original notice. Therefore, the utility has published an Amended Notice of Application for Extension of Service Area, and provided staff with an affidavit for the newspaper publication.
