I, as President of HAUS DEVELOPMENT, INC., am the owner
of 41 Lots of the 49 Lots of the Links Subdivision and object
to the application filed by Florida Water Corporation, Inc.,
(Florida Water) for an Amendment of Territory in Charlotte County
(Docket No. 980261-WS).

I entered into a Water and Sewer Territory Expansion
Agreement dated April 26, 1997 with Lake Suzy Utilities, Inc.
and I consented to the Water and Sewer Service Agreement as
signed by Lake Suzy and Charlotte County on December 9, 1997.
As it stands now, Lake Suzy will be providing water service
and Charlotte County will be providing sewer service which is
the least expensive way to provide service to my lots. Since
Florida Water purchases all its water and wastewater service
from Charlotte County, it would be more expensive to receive
from Florida Water and therefore contrary to my best interest.


