It is my understanding that the two above-noted utilities have reached agreement that certain territory should be deleted from Orchid Springs' territory and added to Garden Grove's territory. This territory appears to encompass more than the two customers who have agreed that they should continue to be served by Garden Grove. Therefore, staff believes that the utilities must comply with the notice provisions of Section 367.045(2)(a), Florida Statutes, and Rule 25-30.030, Florida Administrative code.


