Thank you for your letter in which you protest the notice of application for extension of service area of Rainbow Springs Utilities, L.C. On December 16, 1997, this Commission received the application of the utility for amendment of Certificates Nos. 355-W and 311-S to include additional territory in Marion County. The application was reviewed and found to be deficient because it did not provide the affidavit for newspaper publication. Also, there was a problem with the legal description in the original notice. Therefore, the utility has published an Amended Notice of Application for Extension of Service Area, and staff has requested Rainbow Springs Utilities, L.C., to submit the affidavit for newspaper publication.

On January 13, 1998, the Commission received the protest letter and request for hearing filed on behalf of the Rainbow Springs Homeowners' Association. Based on these letters of protest, a hearing has been scheduled for August 6, 1998, with a prehearing conference scheduled for July 13, ACK 1998. AFA. The Rainbow Springs Homeowners' Association has hired an attorney and will participate as APP a party in this proceeding. However, at this time, we are not sure if you wish to participate as a CAF party, and you have not been designated as a party in this proceeding. If you wish to participate as CMU a party, please advise this office by February 23, 1998. Otherwise, the only recognized parties will be the Homeowners' Association and the utility. CTR EAC.
