Dear Ms. Bayo:

I am writing on behalf of WorldCom, Inc. and its affiliates ("WorldCom") to advise you of the completion of a pro forma change in ownership of WorldCom Technologies, Inc. ("WorldCom Technologies").

By application filed on July 17, 1997, WorldCom sought Commission approval of a corporate reorganization which resulted in a pro forma change in control of WorldCom Technologies. The transactions described in the application included the removal of MFS Network Technologies, Inc. ("MFS NT") from the corporate chain of ownership of WorldCom Technologies. The proposed reorganization was approved by the Commission by order dated September 29, 1997. WorldCom notified the Commission by correspondence dated February 20, 1998 that the planned reorganization had been completed, with the exception of the removal of MFS NT from the chain of ownership of WorldCom Technologies.

This is to inform you that the business issues which delayed the removal of MFS NT from the chain of control of WorldCom Technologies have now been resolved: MFS NT has been removed from the chain of control of WorldCom Technologies, and the stock of WorldCom Technologies is now held directly by MFS Communications Co., Inc. A revised Final Organizational Chart is attached for your information. Since this pro forma change in control had previously been approved by the Commission, we do not believe any additional Commission action is required. If you disagree with our assessment, please inform us as soon as possible.

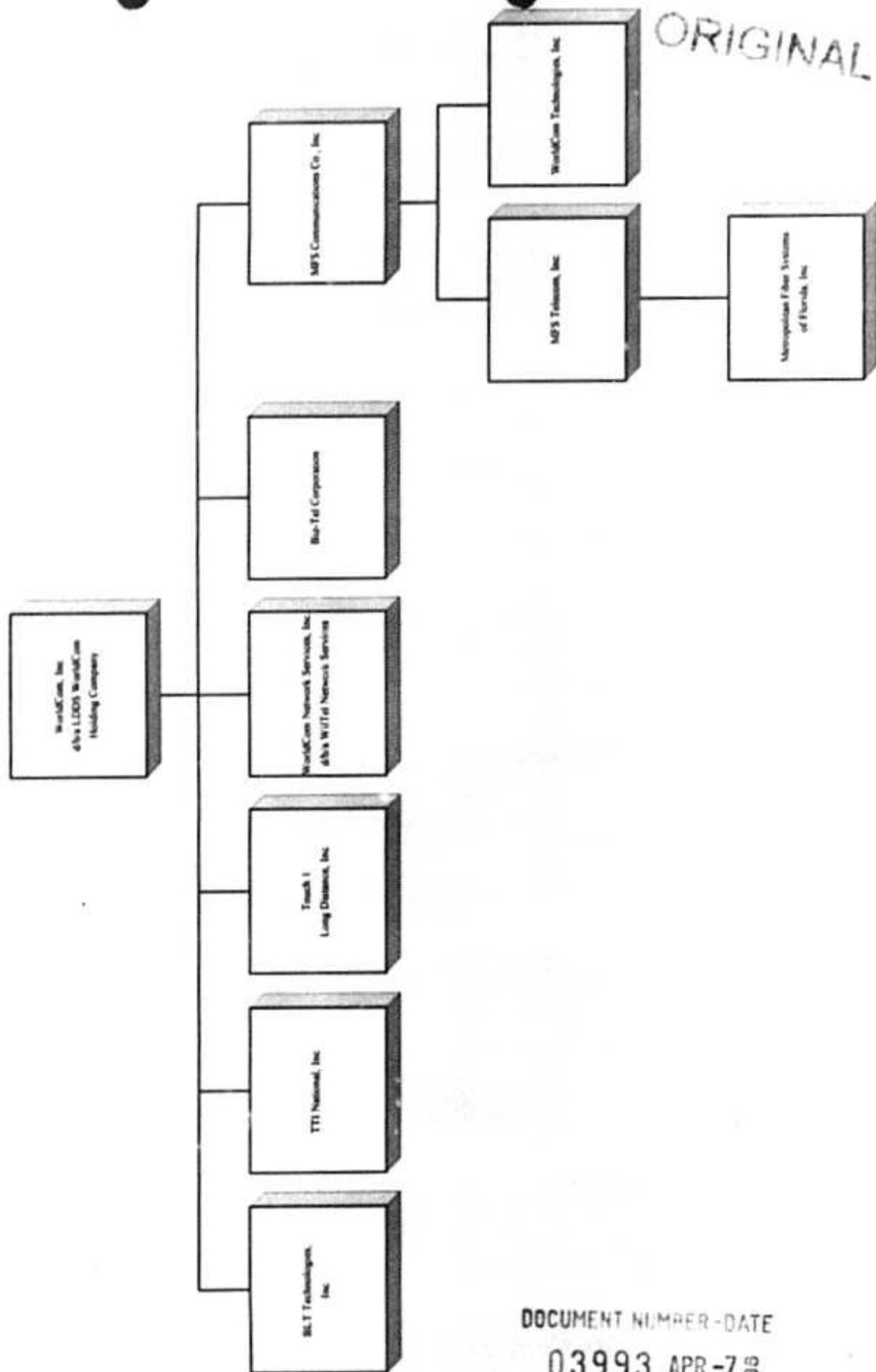
