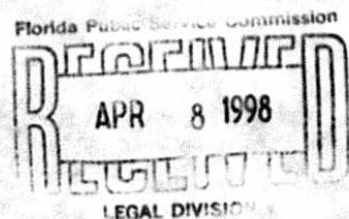
Dear Mr. Ferguson:


Dear Mr. Ferguson,
