Dear Mr. Jaeger:


I see no need to rehash anything that has come up prior to this time, but if you have any questions concerning anything, I would appreciate your asking. I would propose the following in final and complete settlement with anything to do with the PSC which includes all allegations made in the past or to be made in the future concerning Turkey Creek Utilities and/or all of entities and/or persons mentioned in any of your previous correspondence:

1. We will complete the customer rebates on or before April 15, 1998.
2. We will refund \$17.00 x 3 mo. = \$51.00 in late fees to each of the nine customers provided we can reasonably locate them.
3. We will make a rebate of \$25.00 to each of the 26 customers previously mentioned for miscellaneous service charges provided we can reasonable locate them.
4. We will pay to the PSC the sum of \$5,000.00 for them to disburse in any way they care to.
