## ARTICLE I

NAME

The name of this corporation is A.M.K. PETROLEUM ENTERPRISES, INC.

## ARTICLE II

PURPOSE

This corporation is organized for the following purposes:

1. To engage in the business of buying and selling gasoline, kerosene, lubricating oils and greases, anti-freezes, tires, and other supplies for automobiles and tractors. To establish, maintain and operate a gasoline filling stations; to repair tires and lubricate and wash cars; and to do everything ordinarily done by those engaged in that line of business.

2. To establish, maintain, conduct and operate food markets, grocery stores, bakeries and stores of every kind, nature and description; to purchase, buy, sell, exchange, grow, produce, manufacture, process, market, export, import, handle, store, distribute and otherwise generally deal in any and all articles of food, food products, household products, groceries, dairy products, wines, liquors, beverages of all kinds, meat and meat products, vegetables and vegetable products, provisions, produce, fish, poultry and food supplies of all kinds, both at wholesale and retail, and acquire, construct, maintain, operate, buy, sell and deal in stores selling such goods, wares and merchandise.

3. To engage in any other activity or business permitted under the laws of the United States and the State of Florida.

## ARTICLE III

CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of common stock.

2 The common stock of the corporation shall have the following characteristics:

- (a) Par value shall be 10 cents per share.
- (b) At all meetings of the stockholders the common stockholders shall be entitled to cast one (1) vote for each share of common stock owned. That a common stockholder is interested in a matter to be voted upon shall not disqualify him from voting thereon.
- (c) Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding common stock.

#### ARTICLE IV

##### TERM OF EXISTENCE

This corporation shall have perpetual existence commencing on the fifth day of October, 1981.

#### ARTICLE V
