AMENDATORY ORDER

BY THE COMMISSION:

On April 15, 1998, we issued Order No. PSC-98-0515-FOF-TL, requiring implementation of extended calling service (ECS) on certain routes at issue in this Docket. Due to a scrivener's error, however, the second ordering paragraph on page 5 of the Order incorrectly identified the time by which GTE Florida, Incorporated must implement ECS. That paragraph states:

ORDERED that GTE Florida, Incorporated, shall implement extended calling service (ECS) at the rates set forth in the body of this Order on the Haines City/Lakeland, Haines City/Bartow, and Haines City/Polk City routes, as soon as possible, but not to exceed twelve months from the issuance of this Order.

The order shall be corrected to reflect that the time in which GTE Florida, Incorporated must implement ECS on these routes is not to exceed six months from the issuance of Order No. PSC-98-0515-FOF-TL. It is noted that the body of the Order reflected the correct time period; only the ordering paragraph contained the error.

It is therefore

ORDERED by the Florida Public Service Commission that Order No. PSC-98-0515-FOF-TL is amended as set forth herein. It is further

ORDERED that Order No. PSC-98-0515-FOF-TP is reaffirmed in all other respects.


