 - (a) the stated tariff rate, less the wholesale discount; (b) the promotional rate (the promotional rate offered by BellSouth will not be discounted further by the wholesale discount rate)
- 4 Lifeline/Link Up services may be offered only to those subscribers who meet the criteria that BellSouth currently applies to subscribers of those services. In Tennessee, DSE shall purchase BellSouth's Message Rate Service at the stated tariff rate, less the wholesale. discount. BSE must further discount the wholesale Message Rese Service to Lifel ine customers with a discount which is no less than the minimum discount that BellSouth now provides. BSE is respectible for recovering the Subscriber Line Charge from the National Exchange Carriers Association interstate tell settlement pool just as BellSouth does today. The maximum rate that BSE may charge for LifeLine Service shall be capped at the flat retail rate officed by BellSouth.
