**Re: Western Union Communications, Inc.
Tariff Revision and Certificate Cancellation**

Dear Ms. Bayo:

Western Union Communications, Inc. ("Western Union"), by its attorneys, files this letter to accomplish two objectives. First, Western Union seeks to revise its tariff and has attached revised tariff pages (including a blacklined version indicating all changes) for that purpose. The proposed tariff revision reflects a change in the expiration date of Western Union's collectible series cards, a limited edition of 45,000 collector's edition cards that were sold nationwide primarily in 1995. The tariff revision incorporates Western Union's standard expiration language used elsewhere in the tariff. The current tariff language provides that the cards will expire 1 year from first use. As is the case with all other Western Union prepaid calling cards, collectible series cards now will expire 1 year from date of purchase. The tariff's check sheet also has been revised to reflect this change.

Second, Western Union requests that the Commission cancel its certificate effective June 2, 1998. This Commission granted Western Union interexchange resale authority for the provision of prepaid calling cards on January 25, 1995 in Docket No. 941160-TI (Order No. PSC-95-0111-FOF-TI). Western Union, which has been preparing to exit the prepaid calling card business for more than a year, sold its last prepaid calling card on June 2, 1997. Thus, all Western Union calling cards will have expired by the date on which Western Union requests cancellation of its certificate.
