Dear Ms. Bayó:

On March 18, 1997 Florida Power & Light Company ("FPL") forwarded to the Commission by Federal Express a letter dated March 17, 1998 indicating that FPL did not issue any long-term securities in 1997 and, therefore, would not be filing a consummation report. Although Federal Express shows that the letter was received by your office on March 19, 1998, we have been unable to find in your office a copy of that letter. No doubt that was caused in part by FPL not including the docket number on the original letter.

The Staff at the Commission has called FPL about their apparent omission in filing a consummation report in Docket No. 961175-EI. To address the Staff's inquiry and to provide another copy of FPL's original letter for your files, I have enclosed for filing another copy of the March 17, 1998 letter from Dilek Samil to you. The letter is a duplicate of the original letter sent in March.

I understand that you will have to stamp this copy as filed on April 29, 1998 rather than March 19, 1998. The purpose of this letter is simply to create some record in the Commission's file of FPL's earlier filing.
