I HAVE TWO ACTIVE WELLS AND PUMPS ON MY LAND AND I DO NOT NEED TO PAY FOR WATER TO BE PROVIDED FOR ME. THE GOOD LORD UP ABOVE TOOK CARE OF THAT. MY WATER IS GOOD AND HAS NO AFTER TASTE. ALL OF THIS WATER WILL BE TREATED BY FWS WITH CHLORINE AND NO TELLING WHAT ELSE.

I THINK MARION OAKS NEEDS TO TAKE CARE OF MARION OAKS AND LEAVE EVERYONE ELSE ALONE. I AM NOT PART OF MARION OAKS AND DO NOT WISH TO BE SO.

THIS PROPERTY THAT I OWN IS PART OF MY HERITAGE. IT WAS OWNED BY MY GRANDPARENTS BACK IN THE 1920'S WHEN THIS STATE WAS A DECENT PLACE TO LIVE UNTIL ALL THESE NORTHERN PEOPLE STARTED MOVING DOWN HERE AND RUNNING OVER EVERYONE AND CROWDING THE HIGHWAYS AND CAUSING THE INCREASE IN THE COST OF PROVIDING SERVICES TO EACH PERSON. I REALIZE THAT YOU CAN'T STOP PROGRESS, BUT SOMEBODY NEEDS TO TAKE CONTROL OF IT IN MARION COUNTY AND PROBABLY OTHER PLACES TOO.

I CERTAINLY HOPE THAT YOU PUT A STOP TO THIS REQUEST BY FWS.
