In December 1997, Rainbow Springs Utilities published notice of its intent to amend its certificate to include additional territory. Subsequent to that notice, the Commission received approximately 400 letters of protest from apparently those residents of Rainbow Springs living in the areas known as "The Forests" and "The Woodlands."

The Village of Rainbow Springs Homeowners Association, representing those areas, also protested and hired counsel to represent them. Subsequent to that protest, a Prehearing Conference and Hearing were scheduled for July 13, 1998, and August 6, 1998, respectively. The Homeowners Association was granted intervenor status by Order No. PSC-98-0357-PCO-WS.

By letters sent to all protestors, staff asked if the protestors wanted to be considered as intervenors. The staff gave the residents a date certain in which to respond, and, absent any response, advised the protestors that the Homeowners Association would be the only protestor who would be given party status. A few customers responded that they would be represented by the Homeowners Association. Other than those responses, no other responses have been received, and the time given in the letters for filing such has expired.

ACK	Pursuant to negotiations with the Homeowners Association, the utility filed a notice of restrictive amendment to its application deleting the areas known as "The Woodlands" and "The Forests." This restrictive amendment was made contingent upon the Commission recognizing that
AFA	this resolved all protests and obviated the need for a hearing.

CAF .	On May 8, 1998, the Homeowners Association and the utility filed a Joint Stipulation and
CMU.	Settlement Agreement wherein the Homeowners Association has agreed to withdraw its protest.
CTR .	The withdrawal is conditioned on certain language being placed in the Order granting the amendment of certificate. The utility has agreed to the inclusion of that language in the Order.
EAG .	Therefore, it appears that a settlement has been reached, and there is no need for a hearing.

In December 1997, Rainbow Springs Utilities, L.C. published notice of its intent to amend its certificate to include additional territory. Subsequent to that notice, the Commission received timely protests to the utility's application. Accordingly, a Prehearing Conference and Hearing were scheduled for July 13, 1998, and August 6, 1998, respectively.

After correspondence with the protestors, staff was able to determine that the only timely protest remaining was that of the Homeowners Association, and on May 8, 1998, the Homeowners Association and the utility filed a Joint Stipulation and Settlement Agreement wherein the Homeowners Association has agreed to withdraw its protest. Staff will prepare a recommendation for the July 21, 1998 Agenda Conference which will address the utility's application and this joint settlement agreement. Therefore, please cancel the Prehearing Conference and Hearing scheduled for July 13, 1998, and August 6, 1998.
