 NOTICE OF INTENT TO REQUEST SPECIFIED  
 CONFIDENTIAL CLASSIFICATION**

Comes now Sprint Communications Company Limited Partnership ("Sprint"), pursuant to Rule 25-22.006, Florida Administrative Code, and files this its Notice of Intent to Request Specified Confidential Classification.

1. By letter dated April 13, 1998, the Division of Communications of the Florida Public Service Commission ("Commission") requested certain information from Sprint relating to the provision of unbundled network elements ("UNEs") and the status of local exchange competition in the business and residential markets.

2. The information requested by the Division of Communications is in anticipation of request of BellSouth Telecommunications, Inc. ("BellSouth") to provide interLATA services pursuant to Section 271©(1)(A) of the Telecommunications Act of 1996.

3. Sprint responded to the request of the Division of Communications by filing dated May 14, 1998. Sprint's filing indicated that the responses to questions numbered 2(b)(1), 2(b)(2), 3(a)(1) and 3(a)(2) were confidential and proprietary.

4. The information contained in these responses is proprietary to Sprint and includes information containing the number of Sprint's business subscribers and subscriber lines within the State of Florida. This is competitive information and clearly confidential and proprietary under Florida Statutes, Section 364.183 and Rule 25-22.006, Florida Administrative Code.


