I am in receipt of two letters from you, one dated May 11, 1998, and the other dated May 15, 1998. Both of these letters are identical, signed by you, postmarked in Tallahassee May 15, 1998, and were received in our office on May 19, 1998.

I am not surprised to learn that the Commission does not have experience in cases like this as far as payment, etc. After all, how could they? I don't imagine they have very many cases in which they wait 4-1/2 years to try to collect with no prior word going to the alleged debtor. I filed my proposal just as quickly as I could after I was notified and requested an extension. I don't believe I have ever heard anything regarding that request but I assumed they allowed it and the offer that I made was a good conscientious effort to rid myself of the PSC. Turkey Creek Utilities doesn't have but a few dollars in the bank and no assets but I was willing to override this if I could just get the PSC to realize that they are not without fault and to get rid of them.
