NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that Placid Lakes Utilities, Inc.'s petition for variance of Rule 25-30.036(3)(e), Florida Administrative Code, filed December 1, 1997, in Docket No. 971204-WU was approved on February 3, 1998. The rule addresses that a utility provide a description of the territory proposed to be served, using township, ranges, sections, metes and bounds. The petition was approved on the basis that the purpose of the underlying statute would be achieved by other means and application of the rule would create substantial hardship. Notice of the petition was published in the FAW on December 10, 1997.
