This is to confirm the status of the following matters.

1. The matter has been renoticed as a transfer of majority organizational control. Customer notice was mailed June 1; the other renoticing was prior to that date. I will file the necessary affidavits next week.

2. I am revising the tariff to reflect necessary changes, including "cleaning up" the names, etc. If I have questions regarding the model tariff, I'll let you know.

3. We previously discussed the territory description in the notice and agreed on it. I will likely copy the territory descriptions sequentially to bring the tariff up to speed.

4. We are working with the seller to correct the corporate status issue. I expect that the corporation will be reactivated and will provide you proof of same.

5. I will provide you with a simplified organizational chart showing the new relationship between the KW Resort Utilities Corp and WS Utility with the revised tariff.

6. Regarding financial ability, let's discuss how we might handle a staff inspection of personal financial statements.


7. With regard to facility conditions, we have completed the Phase I environmental assessment and will provide you with an updated statement when I file the tariff.
