
Thank you for your May 29, 1998, letter regarding the above-referenced docket. Your letter was in response to my telephone conversation with Ms. Martha Golden on March 13, 1998. I appreciate you forwarding copies of the documentation requested.

I understand the utility has two options: apply for a certificate in accordance with Fla. Stat. § 367.045 or comply with the exemption statute by turning control of the utility over to its customers. I understand you would like for me to advise you of my client's decision by June 12, 1998.

Responding to you by June 12, 1998, may be difficult. Mr. Arnold was recently involved in a severe motorcycle accident where he sustained multiple injuries including the total dislocation of his shoulder, multiple cracked ribs, etc. He was prematurely discharged from the hospital where he developed pneumonia and had to return to the hospital. Nevertheless, I spoke to Mr. Arnold a few days ago prior to receiving your letter and I anticipate I will be able to speak with him soon with regard to this matter.
