
Enclosed is an original and 5 copies of the Initial Application for Quick Take Amendment for Rampart Utilities, Inc. to extend its territory to serve the San Antonio Catholic Church. The application will amend the Wastewater Certificate No. 497-S only.

Within 7 days the utility will be mailing notices to the governing body of the county and municipality, the regional planning council designated by the Clean Water Act, all water or wastewater utilities, the office of Public Counsel, the Commission's Director of Records and Reporting, the appropriate regional office of the Department of Environmental Protection and the appropriate Water Management District, as well as to each customer. Also, within 7 days the utility will cause the notice to be published once in the Charlotte Sun Herald. Copies of the notice and the applicable affidavits will be submitted to the Commission within 15 days of the application.

In accordance with Rule 25-30.036(3), F.A.C., the Follow-Up Application will be filed within 45 days after the completion of the noticing requirements.







**AVAILABILITY OF SERVICE**
