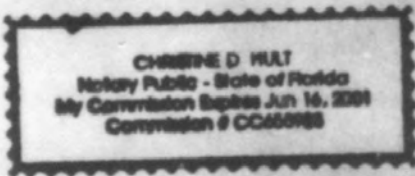

NOTICE TO EKANA GOLF COURSE

The Florida Public Service Commission in Order No. PSC-98-0391-FOF-SU issued on March 16, 1998, approved the application of Alafaya Utilities, Inc. for the implementation of a reuse project plan.
