## REPORT OF MCI TELECOMMUNICATIONS CORPORATION

By Order No. PSC-98-0799-FOF-TP, the Florida Public Service Commission ordered MCI Telecommunications Corporation to provide prospective reductions to its inmate services surcharge on intrastate calls from the state inmate facilities it currently serves in Florida in an amount sufficient to equal \$189,482.49 and to file monthly reports with the Commission until the refund is complete.

MCI notes that its plan of refund filed on July 7, 1998 calls for the surcharge to be reduced for an interim period beginning on August 1, 1998. Accordingly, no amounts were refunded during the month of July.
