

NOTICE OF INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION
OF SPRINT COMMUNICATIONS COMPANY LIMITED PARTNERSHIP

COMES NOW, Sprint Communications Company Limited Partnership ("Sprint") and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Specified Confidential Classification.

1. By letter dated July 10, 1998, the Division of Communications of the Florida Public Service Commission ("Commission") requested certain information from Sprint relating to the status of local exchange competition in the business and residential markets.
2. The information requested will be used by the Commission staff to develop a report on the status of local competition that will be filed with the Governor and State Legislature later this year.
