

OBJECTION OF FLORIDA WATER SERVICE CORPORATION TO
THE APPLICATION OF RAMPART UTILITIES, INC. FOR
AMENDMENT OF CERTIFICATE NO. 497-S IN
CHARLOTTE COUNTY TO EXTEND SERVICE TERRITORY
AND DEMAND FOR FORMAL HEARING

FLORIDA WATER SERVICES CORPORATION (hereinafter referred to as "Florida Water"), by and through its undersigned attorneys and pursuant to Sections 120.569, 120.57 and 367.045, Florida Statutes, and Rule 25-22.036, Florida Administrative Code, hereby files this Objection to the Application of Rampart Utilities, Inc. (hereinafter referred to as "Rampart") for Amendment of Certificate No. 497-S to extend service territory in Charlotte County, and demands a formal hearing thereon, and states that:

- 3. Florida Water received a copy of Rampart's Notice, a copy of which is attached hereto and marked as "Exhibit A" by U.S. Mail on July 8, 1998. The legal description in the notice is confusing, and it is unclear from the notice what territory is to be added. Therefore, Florida Water has filed this Objection to preserve its rights.
- 4. The substantial interests of Florida Water are affected by this application since Florida Water has lines in close proximity and adjacent to the disputed territory which are capable of serving the disputed territory. Florida Water customers will not benefit from economies of scale if Florida Water is not allowed to utilize those lines to serve the disputed territory.
  - The following issues of material fact are currently in dispute:
    - a. Whether Rampart has the technical ability to serve the disputed territory.
    - b. Whether Rampart has the financial ability to serve the disputed territory.
    - Whether Rampart has sufficient wastewater capacity to serve the disputed territory.
    - d. Whether Florida Water can provide service to the disputed territory at a lower cost.
    - Whether it is in the public interest for Rampart to serve the disputed territory.
  - 6. The following ultimate facts are alleged:
    - a. Florida Water has wastewater lines that can be extended to serve the disputed territory.

b.

- Florida Water can provide wastewater to the disputed territory more efficiently.
  - d. It is in the public interest for Florida Water to serve the disputed territory.
- Florida Water is entitled to relief by virtue of Section 367.045, Florida Statutes.

WHEREFORE, Florida Water requests that the Commission:

- a. Hold a formal administrative hearing; and
- b. Deny Rampart's application.

Notice is hereby given that on July 9, 1998, pursuant to Section 367.045(2)(a), Florida Statutes, Rampart Utilities, Inc. Filed an Application for "Quick Take" Amendment to Certificate No. 497-S with the Florida Public Service Commission to provide wastewater service to the following described territory in Charlotte County, Florida.

Being a part of Sections 7, 8 and 18 of Township 40, South, Range 23 East, Charlotte County, Florida, more particularly described as follows:
