To Whom It May Concern:

We are writing to you to help to clarify the circumstances of our re-application for a Pay Telephone Service Provider's Certificate, which we want to have issued in the name of our new corporation Lee-Tele Phone Services, Inc.

Paul and I originally applied for a certificate in our own names as a sole proprietorship, as we are husband and wife. We have since decided to incorporate. When we initially filed for our certificate we were not sure if we wanted to incorporate or not and we were told by someone at the Florida Public Service Commission that there would be no problem if we wanted to change it later. We called after we received our certification from the State of Florida for Lee-Tele Phone Services, Inc. (for the corporation) to let the Florida Public Service Commission know and see what we needed to do to reflect the change. We were told this is a change of name and that it would require re-filing with the FPSC and that we would need to pay a regulatory assessment fee for both names this year and pay another \$100.00 application fee. We asked for another application to be sent to us. When the application did not arrive in about 2 weeks, we called and asked for another to be sent which we just received.

We have a current Florida Public Service Pay Phone Certificate in the name of Paul and Leone Hohl - #5854 and we have a few phones up and running. We would greatly appreciate it if your approval of our new certificate, (under Lee-Tele Phone Services, Inc.), could be coordinated with the cancellation of our current certificate, (#5854 - Paul and Leone Hohl), so as not to interrupt our business. We do intend to pay all applicable fees, file any applicable reports or papers and have enclosed a \$100.00 fee, as we were instructed to do, for the new pay telephone certificate. We also have enclosed a copy of Lee-Tele Phone Services, Inc.'s corporation certification letter from the Secretary of State as proof that we are incorporated in the State of Florida. We will surrender our original certificate as you deem the appropriate time.

We appreciate and thank you for your assistance in this change over.
