

Dear Mr. Walbert:

According to the Commission's Division of Administration's records, you owe \$66.50 for regulatory assessment fee (RAF), which includes statutory penalties and interest, broken down as listed below:

\$50.00 - 1998 RAF
 12.50 - 1997 Penalty
4.00 - 1997 Interest
 \$66.50

Rule 25-24.514(2) (a) (b), Florida Administrative Code, Cancellation of a Certificate, states:

- (2) If a certificated company desires to cancel its certificate, it shall request cancellation from the Commission in writing and shall provide the following with its request:
- (a) State of intent and date to pay Regulatory Assessment Fee.
 - (b) State of why the certificate is proposed to be cancelled.

The only thing the Commission received from you was a note at the bottom of the 1997 RAF form advising "Please cancel my certificate as of 1/1/98". Therefore, you are correct that you do not have to go ahead and pay the 1998 RAFs. However, you must comply with the above rule as to your intent to when you will pay the 1998 RAFs. Any penalties and interest for prior years is already pay due and needs to be paid before I can proceed with your cancellation. Also, the effective date of your cancellation will be the date the Commission received your request, not January 1, 1998.
