REQUEST FOR CONFIDENTIAL CLASSIFICATION**

Pursuant to Rule 25-22.006, Florida Administrative Code, ACI Corp. d/b/a Accelerated Connections, Inc., ("ACI"), hereby files its Request for Confidential Classification. On this date, ACI is filing its application in the above-styled case. ACI is filing its Request for Confidential Classification of its financial statements because they contain confidential and proprietary business information.

As grounds for this request, ACI states that its financial statements contain information which is required to be submitted to the Commission as part of its Application for Authority to Provide interexchange telecommunications service. However, ACI is a private, closely held corporation whose financial information is maintained as highly confidential and proprietary.

Public disclosure of this information would materially damage ACI's competitive and financial position. It would provide ACI's competitors with access to confidential and proprietary information about ACI's capital structure, liquidity, assets and other valuable confidential financial information. This information could then be disclosed to other parties or otherwise used in a manner detrimental to ACI. Such a situation would provide ACI's competitors with an unfair advantage in the marketplace as this same information on competitors' businesses would not be available to ACI. On that basis, ACI's Financial Statements should be classified as proprietary and confidential information, and should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.


