Your bill has two changes. The FCC has altered the way long distance carriers pay access fees to local phone companies. AT&T is now recovering some of its average per customer access costs in the form of a monthly Carrier Line Charge of \$0.85/account. Also, the extended Universal Service Fund now not only helps provide affordable phone service but also gives schools and libraries access to the Internet.
