National Tel hereby files pursuant to Rule 25-22.006, Florida Administrative Code, its Request for Confidential Classification, and states the following:

1. By letter dated July 10, 1998, the staff of the Florida Public Service Commission requested National Tel to provide responses to its data request in connection with the above-captioned matter.

2. On September 16, 1998, National Tel filed its data request responses with a Request for Confidential Classification.

3. The information provided in response to staff's request includes the exact number of business and residential access lines and the specific exchanges where National Tel provides local service. This information directly relates to National Tel's competitive interests. Disclosure of this information would impair

the competitive business interests of National Tel by allowing competitors to determine the specific markets where National Tel conducts its business and to determine the exact number of access lines for residential and business services.

6. One highlighted copy of the information with the material which is confidential and proprietary is attached hereto in a sealed envelope as Attachment "C."


