FPSC-RECORDS/REPORTING

This Resale Agreement (the "Agreement"), is made effective as of October 6, 1998, by and between GTE Florida Incorporated, with its address for purposes of this Agreement at 600 Hidden Ridge Drive, Irving, Texas 75038 ("GTE"), and Frontier Telemanagement, Incorporated, in its capacity as a certified provider of local dial-tone service ("Frontier"), with its address for this Agreement at 180 South Clinton Avenue, Rochester, New York 14646 (GTE and Frontier being referred to collectively as the "Parties" and individually as a "Party"). This Agreement covers services in the state of Florida only (the "State").

WHEREAS, Section 251 of the Telecommunications Act of 1996 (the "Act") imposes specific obligations on LECs with respect to the resale of telecommunications services;

NOW, THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, GTE and Frontier hereby covenant and agree as follows:
