CHAIRMAN JOHNSON: Good morning, ladies and gentlemen. We're going to go ahead and call this hearing to order.

My name is Julia Johnson. I'm Chairman of the Florida Public Service Commission and I'll be presiding over the customer hearing this morning. Counsel, please read the notice.

MS. McKINNEY: Notice published August 7th, 1998, this time and place was set for a public hearing in Florida Public Service Commission's Undocketed Special Project 980000A. The purpose of this hearing is to elicit public testimony regarding the fair and reasonable Florida residential basic local telecommunications service rates.

CHAIRMAN JOHNSON: Thank you. Again, I'm Julia Johnson. I'm the Chairman of the Florida Public Service Commission. Standing to my left is Commissioner Leon Jacobs, seating next to him is Commissioner Susan Clark, to my right is Commissioner Terry Deason and to his right is Commissioner Joe Garcia.

As you walked in you probably received a blue information sheet. That gives you a lot of

background as to why we're here today, but let me just briefly go through some of the details.

Last session the legislature passed House
Bill 4785. And as a part of that bill they asked that
the Commission study and report back to the
legislature for the 1999 session the fair and
reasonableness of local residential rates. As a part
of that process, we're holding 22 public hearings
across the state to receive input and suggestions and
concerns from all of the customers in the state of
Florida.

If you look, too, to the sheet, it provides other means by which you could provide us with your comments. For those of you who don't want to provide oral comments today, in the back of this sheet there's a place where you can write written comments. You can hand those in to our staff members that are present here today. Or if you go home tonight and think about it and want to provide more comments, feel free to mail that in. We also have our Internet site listed, if you want to file your comments or Commission complaint via the Internet, that process is available and our 1-800 number.

The purpose of this process and the intent of the legislature was us to hear from you, again,

your thought on local rates, local service, how -- if you have any suggestions as to how we might promote the competition. I know we were in the Hillsborough-Pinellas area yesterday and we received lots of good input from the customers with respect to not only their thoughts on the local rates, but ideas as to what we could do and should do to promote bringing competition and choice to the local markets.

And with that, let me tell you before I ask
you to stand for those of you who would like to
testify, that we do swear in the witnesses. We have a
court reporter here that is recording all of your
statements, and we do that so we can use your
testimony as a part of the official record that we can
rely upon when we make our final recommendations to
the legislature.

Also, if you'd like to, at your leisure, and if you have the computer equipment necessary, you can go to our Web Page and download the audio provision of these hearings. All of them have been recorded. They are assessable via the Internet, and if you have a computer with the appropriate equipment, to hear what your neighbors across the state have stated on this issue.

So with that, if you could, those of you who

would like to testify, if you could stand I'll swear 1 2 you in at this time. 3 (Witnesses collectively sworn.) 4 One other preliminary matter. Let me at 5 this time, because Public Counsel will be calling you forward, let me go ahead and take appearances of the 7 attorneys that are here. 8 MR. BECK: Thank you, Chairman Johnson. My name is Charlie Beck. I'm with the Office of Public 9 10 Counsel in Tallahassee, and I'm appearing for the Florida citizens. 11 12 CHAIRMAN JOHNSON: Thank you, Mr. Beck. 13 MS. McKINNEY: June McKinney on behalf of Staff. 14 15 CHAIRMAN JOHNSON: Thank you, Ms. McKinney. I think we're then prepared for our first witness. 16 17 MR. BECK: The first witness is Dorothy 18 Treadwell. WITNESS TREADWELL: Good morning, ladies and 19 20 gentlemen. I come from Grant, Florida, but I live 21 right near --CHAIRMAN JOHNSON: I'm sorry, ma'am, and I 22 23 apologize for cutting you off, but I didn't give all of the necessary instructions. 25 If you could, as you come forward, I know

that Mr. Beck stated your name, but if you could again state your name for the record, and where you're from.

#### DOROTHY TREADWELL

was called as a witness on behalf of the Citizens of the State of Florida and, having been duly sworn, testified as follows:

#### DIRECT STATEMENT

Treadwell, and I come from Grant, Florida, which is between Melbourne and Vero Beach. I live near Barefoot Bay community which has over 9,000 people, and most of them are older people and senior citizens. And I feel, personally, between myself and the people I've spoken to, that an increase in rates would be very detrimental to these people. An awful number of them are living on Social Security. And with the cost of medical care and everything else, they find it very difficult to exist. And they really need telephone service because it's the only way of communications for — a lot of these people are homebound.

So I feel personally, and I feel for these people, and I'm representing a lot of them down there, that really, they cannot afford an increase. For some people a \$2 increase is nothing. But for these people

on a limited income it means buying food or paying for medicine or things like that.

So this is why it's so important for us to consider the older people in those communities that would be the ones to suffer the most from any kind of increase.

If you look at the telephone bill compared to few years ago, it's gone up completely, way up out of line. Besides, they put in these extra services to pay for the computers in the schools, which I think is unnecessary because we have computers in the libraries anyway. All this sort of stuff is really adding a terrible burden to the elderly people in this country.

Thank you.

CHAIRMAN JOHNSON: Thank you, ma'am.

MR. BECK: The next witness is George Perez.

#### JORGE "GEORGE" PEREZ

was called as a witness on behalf of the Citizens of the State of Florida and, having been duly sworn, testified as follows:

#### DIRECT STATEMENT

MR. PEREZ: Good morning. My name George
Perez. I am living at 4718 Lake Trudy Drive in
St. Cloud, Florida. Area code 32769.

Distinguished members of the Florida Public Service Commission. I am a member of the AARP board of the 15th Congressional District in Florida, which covers Osceola, Brevard, Indian River, and part of Polk County.

I appreciate this opportunity that you have given me to express the concern of the thousands of senior citizens of Florida's 15th Congressional District who will be affected by an increase in the rate of telephone service.

The telephone is an indispensable means of communication for many citizens who are unable to walk or drive, to go out for themselves in order to secure the necessities of life. The telephone is essential for their every day lives, and if they cannot afford the cost of this service, their lives may be at risk.

Thousands and thousands of senior citizens are living from a small Social Security pension, and for many of them, the increase considered for their phone service could reach up to 70% of the current rate. While it can seem a small amount for the members of the Florida Public Service Commission, it really represents a big amount to the senior citizens who are living on small pensions.

In the name of senior Citizens of Florida's

Kissimmee-St. Cloud, I always pronounce Kissimmee wrong. Do you have any opinion on the area code split or don't you?

MR. PEREZ: Okay. I do not have any business. I think the effect for the residential telephone will be very limited. But people with businesses, I think that would be, you know, a bit of a hardship.

COMMISSIONER GARCIA: One of the options
that the business people have spoken about so that
nobody's phone changes is to have 10-digit dialing.
In other words, you dial the area code that you now
have plus the seven numbers of your home phone number.
And that -- and I think the reason -- at least
mentally I'm considering that much stronger is because
of the great confusion in dividing Orlando. Do you
think that's a reasonable option? Or you would rather
just have a split of some sort in the Orlando area?

know, you can find out why the area with more business, concentration of more businesses are going 3 to be affected, maybe, you know, keep this area with 4 the same area code they have now. 5 COMMISSIONER GARCIA: You would favor a 6 geographic split? 7 MR. PEREZ: Yeah. 8 COMMISSIONER GARCIA: And probably keeping 9 the 407 in the larger business, more densely populated 10 business areas. 11 MR. PEREZ: That's right. 12 COMMISSIONER GARCIA: I appreciate that. 13 MR. PEREZ: I don't think, you know, the affect on residential will be too big. SAL GIOVENCO

was called as a witness on behalf of the Citizens of the State of Florida and, having been duly sworn, testified as follows:

#### DIRECT STATEMENT

WITNESS GIOVENCO: Good morning, ladies and gentlemen. My name is Salvatore Giovenco.

G-I-O-V-E-N-C-O. I'm Associate State Coordinator for Community Operations of AARP. That entails my having control over seven counties in the northeast part of Florida. However, I'm not here to speak for all of those people. I'm here to speak on behalf of myself and a number of people that belong for my local Chapter 4149 here in Orlando.

I had the honor of addressing them Tuesday. Some of them indicated they couldn't make this meeting. However, you do have one this evening, I believe, at the Orlando City Hall. So I expect some of them to be there tonight. However, I did distribute a letter with your address on it and told them if they had any comments, to please go ahead and write to the Commissioners.

Having said all of that, I have too little questions. First, this raise anticipated to improve our equipment for the telephone companies and service?

Does anyone have an answer to that?

CHAIRMAN JOHNSON: First, let me take a step back. We are looking at a broad set of issues. And I generally say at the beginning of these hearings that we're holding these hearings not pursuant to any anticipated increase, and that the legislature in the legislation doesn't say anything about an increase at this time. Certainly that will be one of the things they will consider. But as the industry members have argued and discussed and educated the legislature as their point of view, I believe the argument is that perhaps local service is priced below cost. And in order to get competitors to come in and build infrastructure and bring about advanced technology, they need to raise the rates. That would probably be the argument of the companies. Certainly there will be arguments on the other side. Public Counsel will present arguments and positions, as will the Attorney General. And then we'll use that information and forward it to the legislature. But there is that argument being made, about if you increase the rates, you will provide the necessary incentives for companies to come in.

WITNESS GIOVENCO: Thank you. That was very good.

My second one is when and if this raise should take effect, will this be gradually increased on our telephone bills, or is this going to be an impact immediately on our telephone bills?

CHAIRMAN JOHNSON: That's another question that I don't have a direct answer for because I'm not even sure the Commission will recommend an increase. But I would think generally when we have our regulatory policies we always look at if -- and this is a big if -- if there was ever the suggestion of an increase, we always look at the rate shock issue and how much can the customers actually bear. Even the legislature last year, when they were doing some initial legislation and there was a committee bill, even that bill had a gradual increase of the residential rates, but it also had a reciprocal decrease in the access rates looking at trying to keep total bills lower.

I'm sure as we do our analysis we would do something similar to not provide rate shock. Because the legislature and the Commission, we're all still committed to the concept of universal service. Making sure that everyone is still a part of the telecommunications network and that we all have that access.

WITNESS GIOVENCO: Oh. Thank you.

Let me just close by saying, AARP has not actually taken a stand against or for any raise. And I say that not based on the 2 million-plus members we have in the state of Florida, but from talking to some executives up in the state office. We feel that if the raise is -- has to come, we hope it will be considering the people that we have on Social Security, which many, many of our members are. And that's their only source of income. Therefore, any raise is going to be a hardship on these people. And we hope that's a consideration the Commission will take when they make their final decision. Thank you very much for the time.

COMMISSIONER GARCIA: Mr. Giovenco, what part of this area are you from?

WITNESS GIOVENCO: I'm sorry. I'm from Orlando on the east side.

COMMISSIONER GARCIA: East side.

WITNESS GIOVENCO: If you took I-4 east, get
off near Semoran Boulevard.

COMMISSIONER GARCIA: Okay. Let me just tell you that we have been very pleased with AARP's participation on this. And we have yet -- unless the places I went to -- at least all of the hearings I

with a \$10.50 credit off of their local phone bill.

about the program because there's a low subscribership. Not too many people are actually using that program. Several reasons have been articulated. But what AARP members have told me, as well as the NAACP, is that people just don't know about the program. And that they want to help us be, perhaps, our implementers throughout the community of letting people know that the programs are available. They are available to, again, economically disadvantage those on food stamps, supplemental Social Security and those kind of programs.

We will provide you with any information, if that would be helpful, on that program, and another program called Link Up. And that's for new people moving to the community that also may be disadvantaged. It's a \$30 credit off of their initial connection fee.

Now, those two programs are available.

Ms. Crump standing there in the back, she has some information on them. But I must tell you that we are

reviewing those programs through this process too.

Some have suggested we go to an automatic enrollment so that if you receive this supplemental assistance, that you automatically are enrolled. Some people object to that. Others have stated that the companies could do something as simple as an application, provide that to AARP. And then AARP could help distribute, as well as the double NAACP and Florida Consumer Action Network, those kind of groups. We'll be exploring that. Some have suggested that we should expand the program to not just have the delineated category that we have now because there are other people that are in need.

So I just wanted to tell you that because of your leadership and your involvement. And we will be working, the Commission, to make recommendations to the legislature on those programs, as well as your organizations and others.

witness GIOVENCO: Thank you. It's very interesting. And I thank you all for the time.

MR. BECK: Chairman Johnson, Mr. Giovenco is the last witness to have signed up. I believe
