Dear Sir:

I am writing in response to the " legal notice" given on September 23, 1998 pursuant to Section 367.071, Florida Statutes, of the application for the transfer of Certificate Nos. 495-S from Sandalhaven Utility, Inc. to Utilities, Inc. of Sandalhaven to provide sewer service in Charlotte County, Florida.

My objections are as follows:

- 1.) In re: Application for transfer of Certificate No. 495-S from Sandalhaven Utility, Inc. to CHP Utility, Inc. in Charlotte County, Florida. Cancellation of Certificate No. 495-S, and exemption from Florida Public Service Commission regulation.

ISSUED: September 21, 1998

This Order provides that within 45 days CHP Utilities, Inc. shall provide proof that all assets transferred to CHP have been transferred back to Sandalhaven. As of this date no proof has been provided.


This Order also provides that upon receipt of proof of this conveyance of the utility assets and facilities to Sandalhaven Utility, Inc., Certificate No. 495-S shall be reinstated. As of this date no proof has been provided.

- 2.) The records of the Florida Environmental Protection Agency located in Fort Myers, Florida will show that:

This particular plant is operating above 70% level, which is considered maximum capacity. That this plant was due for renewal license in June of 1998. No proof of renewal has been provided as of this date.

- 3.) That the records of the Florida Environmental Agency and the Charlotte County Health Department will show that for the last four years, this plant has not been operated in the best interest of the people of Florida. There has been raw sewage flowing from the plant and its lift stations on numerous occasions. I have grave health concerns for myself and my wife who are both disabled, my family who visit, my neighbors, the value of my property (which the tax duplicate has devalued by \$8,860.00 just this year alone), and my community in which I am so proud to live.
