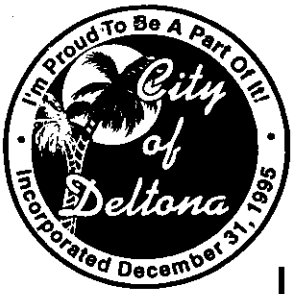

RESOLUTION NO. 98-58

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA; SUPPORTING ACTION BY THE PUBLIC SERVICE COMMISSION (PSC) TO ALLEVIATE TELEPHONE COMMUNICATION PROBLEMS WITHIN THE CITY OF DELTONA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, residents, business owners, and local government service providers within the City of Deltona experience telephone communication difficulties and added cost due to the current division of the City into two telephone area codes, 904 and 407; and

WHEREAS, the addition of a third area code would be detrimental to all Deltona residents and business owners; and

WHEREAS, an area code overlay in the City would divide the City in half by requiring that half of Deltona's residents dial 10-digits for local calls and the other half being able to dial 7-digits for local calls; and

WHEREAS, the City's municipal complex and outlying facilities (fire stations and Public Works' field operations site) could be divided among three (3) area codes within the City of Deltona City limits; and

WHEREAS, the City is now divided into different long distance calling zones as well, requiring some residents to pay long distance charges to call the Daytona Beach area or the Orlando metropolitan area; and

WHEREAS, the combination of several communication difficulties/anomalies warrants further investigation by the Public Service Commission prior to adding additional confusion by applying a third area code to the Deltona area.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA, as follows:



SECTION 3. That this Resolution shall become effective immediately upon its adoption.



SECTION 3. The City Council of Satellite Beach urges the Public Service Commission retain the present 407 area code for the residents of the City and Brevard County.



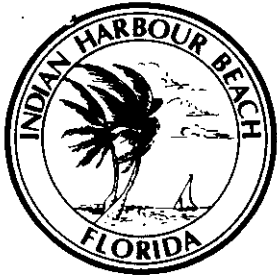

WHEREAS, the City Council of the City of Indian Harbour Beach, Florida feels that a split area code will create a hardship for Brevard County residents and businesses;


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Indian Harbour Beach, Brevard County, Florida that:


