

BELLSOUTH TELECOMMUNICATIONS, INC.'S NOTICE OF INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, inc. ("BellSouth" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Specified Confidential Classification.

1. On October 16, 1998, BellSouth filed its Late-Filed Deposition Exhibit No. 1 for Jerry Rubin and Exhibit No. 1 for W. Keith Milner. BellSouth is now filing a Notice of Intent to Request Specified Classification. The Late-Filed Exhibit contains information considered to be confidential and proprietary to BellSouth in the above captioned docket.

2. The information contained in these documents is proprietary to BellSouth and includes information containing, among other things, vendor-specific and confidential business information. Vendor pricing is associated with switch equipment for BellSouth's central offices. Vendor specific pricing is negotiated by BellSouth and public disclosure of this information would impair BellSouth's ability to contract for goods and/or services on favorable terms. Pursuant to Section 364.183, Florida Statutes such information is classified as

proprietary, confidential business information which is exempt from the Open Records Act.

3. Information responsive to this request also contains competitive business information about the type and quantity of equipment that BellSouth has placed in its central office in 1998. Competitors of BellSouth could use this information to determine the types of customers and services that BellSouth is marketing in this particular central office. Thus, the disclosure of this information to BellSouth's competitors would impair BellSouth's ability to compete. Thus, this information is a trade secret which should be classified as proprietary, confidential business information exempt from the Open Records Act pursuant to Section 364.183, Florida Statutes. This information is clearly confidential and proprietary under Florida Statutes, Section 364.183 and Rule 25-22.006, Florida Administrative Code.

4. Because this information contains proprietary information, BellSouth is filing this Notice of Intent to Request Specified Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Commission to take possession of the production responses and to inspect the documents without delay. The original of this notice has been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information.
