

1. On August 4, 1998, Supra Telecommunications and Information Systems, Inc. ("Supra") served its First Request for Production of Documents, Nos. 1 through 22 on BellSouth. On September 3, 1998, BellSouth filed its Responses and Objections to Supra's First Request for Production, and produced certain confidential documents pursuant to a Protective Agreement. On October 13, 1998, Staff requested a copy of these documents. In order to allow Staff to have copies of certain documents, specifically Request for Production Nos. 6, 8, 9, 17 and 19, BellSouth is now filing a Notice of Intent to Request Specified Classification for Request for Production Nos. 6, 8, 9, 17, and 19. The responses to this discovery contain information considered to be confidential and proprietary to BellSouth in the above captioned docket.

2. On September 15, 1998, Supra served its Second Request for Production of Documents, Nos. 23 through 56 on BellSouth. On September 23, 1998, BellSouth filed its Objections to Supra's Second Request for Production,

3. The information contained in these documents is proprietary to BellSouth and includes information containing, among other things, vendor - specific and customer-specific information. This information is clearly confidential and proprietary under Florida Statutes, Section 364.183 and Rule 25-22.006, Florida Administrative Code.
