

**JOINT MOTION TO ACCEPT JOINT POST-HEARING BRIEF
IN EXCESS OF PAGE LIMITS**


Comes now AT&T Communications of the Southern States, Inc. ("AT&T"), MCI Telecommunications Corporation ("MCI"), and WorldCom Technologies, Inc. ("WorldCom") and jointly request the Commission to waive the page limitation on post-hearing statements and accept the Joint Post-Hearing Brief submitted by AT&T, MCI and WorldCom. As basis the parties would state:

1. In Order No. PSC-98-1303-PHO-TP, issued October 8, 1998, the Prehearing Officer directed that a "party's proposed finding of fact, conclusions of law, and if any, statement of issues and positions", and brief shall together total no more than 50 pages . . ." Each party to this proceeding thus is entitled to submit a post-hearing statement of 50 pages or less.
2. AT&T, MCI and WorldCom as individual parties could, pursuant to the Prehearing Order, submit three separate post-hearing statements which would total 150 pages. However, these three parties have prepared a joint post-hearing brief of 73, which exceeds the 50 page limit but is less than the total pages which could be submitted. This single filing not only reduces the documents to be reviewed by Staff and the Commission in this docket, but also reduces the individual positions which must be analyzed. If each party were to file separate statements, there would be three separate positions to restate and analyze. The single document reflects the joint position of the parties and the position need only be analyzed once rather than three times.


3. By accepting the Joint Post-Hearing Brief, the Commission will realize benefits and efficiencies. At the same time, no party will be affected or prejudiced.

Therefore, AT&T, MCI and WorldCom respectfully request the Commission to accept the Joint Post-Hearing Brief.




