

NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that Gulf Power Company's petition for waiver of Rule 25-17.015(1), Florida Administrative Code, filed August 3, 1998, in Docket No. 980973-EG, was approved by the Commission at its September 22, 1998, Agenda Conference. Order No. PSC-98-1360-FOF-EG, issued October 12, 1998, memorialized the decision. The rule addresses the filing schedule and guidelines for utilities seeking recovery of costs for energy conservation programs. The petition was approved on the basis that the purpose of the underlying statute would be achieved by other means and application of the rule would create substantial hardship. Notice of the petition was published in the FAW on August 21, 1998.
