This is a follow up to staff's telephone conversation of September 17 with you. I will hold off opening a docket to cancel your company's certificate until September 30. This will allow you time to pay your 1997 RAFs plus statutory penalties and interest for the years 1997, 1996, and 1994.

According to the Division of Administration, your company owes \$77.31. The amount includes \$50.00 - 1997 RAFs; \$12.50 - 1997 Penalty; \$4.50 - 1997 Interest; \$7.50 - 1996 Penalty; \$1.50 - 1996 Interest (1996 RAFs paid 03/31/97); \$1.09 - 1994 Penalty; and \$.22 - 1994 Interest (1994 RAFs paid 03/25/95). The 1997 RAF form is enclosed. Please complete the RAF form and return it, along with your check for the full amount due, to be received by the Commission by September 30. The RAF form and check are to be mailed to the Fiscal Section, Division of Administration. However, a copy should be sent to my attention so that I will know you have paid.
