I have attempted to call you at (305) 945-8079 twice and each time received a ring, no answer. I wanted to let you know that I am getting ready to cancel your pay telephone certificate for nonpayment of 1997 regulatory assessment fees. I will hold off opening the docket until October 30, 1998. This will allow you time to call me so that we can discuss this pending action.

As information, the Commission mails the RAF notices each year in December and RAF payments are due by January 30 of the following year to avoid penalties and interest. As of this date, the Commission has not received your payment. The amount that is currently past due is \$67.50. In addition, a pay telephone company must pay at least \$50 in regulatory assessment fees to the Florida Public Service Commission each year if it is regulated for any day during that calendar year. Therefore, since we have not received a written request from you requesting cancellation of your certificate, your company is still active. This means that even if the Commission cancels your certificate for rule violations, you will still owe the minimum 1998 RAFs in addition to the amount already past due and any fine ordered by the Commission.
