ORDER GRANTING REQUEST FOR CONFIDENTIAL CLASSIFICATION

In accordance with the new Chapter 98-277, General Laws of Florida, the Commission is required, among other things, to study and report to the Legislature, by February 15, 1999, its conclusions regarding the fair and reasonable rate for Florida residential basic local telecommunications service. In order to effectuate the timely completion of the required report, the Commission has established this matter as Undocketed Special Project No. 980000A-SP, Fair and Reasonable Residential Basic Local Telecommunications Rates. In conjunction with this Special Project, this Docket has been opened for discovery purposes related to the project.

On August 21, 1998, BellSouth Telecommunications, Inc. (BellSouth) filed requests for confidential treatment of Document Nos. 08205-98, 09085-98, which contain BellSouth's responses to Commission staff's data requests 1(b), 1(d), 1(f), 1(h), 1(j), 2(b), 3(b), 4(b), 5(a), and 5(b) and of Document Nos. 08089-98, and 09087-98, which contain its response to Commission staff's data request Item 5.c. BellSouth asserted that its responses contain confidential information that should be exempt from Section 119.07(1), Florida Statutes. On August 26, 1998, BellSouth submitted its supplemental responses to Commission staff's data requests 1(b), 1(d), 1(f), 1(h), 1(j), 2(b), 3(b), and 4(b), Document No. 09290-98. BellSouth argues that the information contained in these documents is information, which, if disclosed, would impair its ability to compete. BellSouth asserts that it treats this information as confidential and that the information has not otherwise been disclosed. BellSouth asks, therefore, that this information be granted confidential treatment, in accordance with Rule 25-22.006, Florida Administrative Code. It is noted that the request was filed in related Undocketed Special Project No. 980000A-SP. It is, however, appropriate that this request be addressed in this Docket.

Florida law presumes that documents submitted to governmental agencies shall be public records. The only exceptions to this presumption are the specific statutory exemptions provided in the law and exemptions granted by governmental agencies pursuant to the specific terms of a statutory provision. This presumption is based on the concept that government should operate in the "sunshine." Rule 25-22.006(4)(c), Florida Administrative Code, provides that it is the Company's burden to demonstrate that the documents fall into one of the statutory examples set out in Section 364.183, Florida Statutes, or to demonstrate that the information is proprietary confidential information, the disclosure of which will cause the Company or its ratepayers harm.

Specifically, as it pertains to Document Nos. 08205-98, 09085-98, and 09290-98, BellSouth asserts that the information contained in these documents includes cost studies, associated work papers and related documentation for the contribution analyses submitted in response to Commission staff's data requests. BellSouth also states that the information contains marketing studies, reports and analyses that pertain to the price, quantity and demand for BellSouth products and services, as well as consumer consumption information and vendor contractual information. BellSouth asserts that public disclosure of this information would give BellSouth's competitors an unfair advantage in the market by allowing them to benefit from BellSouth's research. Attached and incorporated into this Order as Attachment A is a list of the specific items, lines, and page numbers for which BellSouth seeks confidential treatment.

Regarding Document Nos. 08089-98 and 09087-98, BellSouth states that it seeks confidential treatment of this information because it ". . . includes work papers and documents used in the development and determination of the depreciation parameters provided by BellSouth in response to Items 5.A and 5.B." BellSouth asserts that public disclosure of this information would allow competitors to unfairly benefit from BellSouth's research and development of this information. BellSouth further asserts that it treats this information as valuable, confidential business information. Attached and incorporated into this Order as Attachment B is a list of the specific items, lines, and page numbers for which BellSouth seeks confidential treatment.

Section 364.183(3), Florida Statutes, states that proprietary confidential business information is information that

. . . is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to the ratepayers or the person's or company's business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public.

Based on the definition of proprietary confidential business information in Section 364.183(3), Florida Statutes, it appears that the information for which BellSouth seeks confidential classification is information that, if disclosed, would cause harm to the company or its ratepayers because disclosure would violate Section 364.24, Florida Statutes. Thus, this information qualifies as proprietary business information under Section 364.183, Florida Statutes, and Rule 25-22.006, Florida Administrative Code. It shall, therefore, be granted confidential treatment in accordance with those provisions.

It is, therefore

ORDERED by Commissioner Susan F. Clark, that the August 21, 1998, Request for Confidential Classification of Document Nos. 08285-98, 09085-98, 09290-98, 09087-98, and 08089-98, filed by BellSouth Telecommunications, Inc. in Undocketed Special Project No. 980000A-SP is hereby granted. It is further

ORDERED that pursuant to Section 364.183, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, any confidentiality granted to the material specified herein shall expire eighteen (18) months from the date of the issuance of this Order in the absence of a renewed request for confidentiality pursuant to Section 364.183, Florida Statutes. It is further

ORDERED that this Order will be the only notification by the Commission to the parties concerning the expiration of the confidentiality time period.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.038(2), Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.

- A. This information contains actual unit cost information for discrete cost elements for the services under study. These costs reflect BellSouth's Total Service Long Run Incremental Cost of providing these services on a going-forward basis. Public disclosure of this information would provide BellSouth's competitors with an advantage in that they would know the price or rate below which BellSouth could not provide the service. The data is valuable to competitors and potential competitors in formulating strategic plans for entry, pricing, marketing and overall business strategies concerning these services. This same information on competitors is not available to BellSouth. This information is valuable, it is used by BellSouth in conducting its business and BellSouth strives to keep it secret. Therefore, such information is a trade secret which should be classified as proprietary, confidential business information pursuant to Section 364.183, Florida Statutes, and is exempt from the Open Records Act.
- B. This information reflects vendor specific information in two categories—1) vendor specific prices or 2) trade secret information which is proprietary to Bellcore. Vendor specific prices are negotiated by BellSouth with its vendors. Public disclosure of this information would impair BellSouth's ability to contract for goods and services on favorable terms. The second category of vendor specific information constituting a trade secret is that which is proprietary to Bellcore. Contained within the subject protected information is information from the SCIS (Switching Cost Information System) model developed by Bellcore. There is also information in the SNC (Switched Network Calculator) model of BellSouth that is derived from the SCIS. The SCIS is a model that Bellcore considers to be proprietary, and BellSouth is contractually bound by an agreement with Bellcore to treat it as such. This model incorporates information given to Bellcore by switch vendors, as well as programming algorithms developed by Bellcore to translate the switch vendor information into cost profiles for various applications. This computer model has been developed by Bellcore over the course of more than a decade at a cost of tens of millions of dollars. If any of this information were made publicly available, the value of Bellcore's model and the related services it provides would decrease dramatically. This information is valuable, it is used by BellSouth in conducting its business and BellSouth strives to keep it secret. Therefore, such information is a trade secret which should be classified as proprietary, confidential business information pursuant to Section 364.183, Florida Statutes, and is exempt from the Open Records Act.

The second category of vendor specific information constituting a trade secret is that which is proprietary to Bellcore. Contained within the subject protected information is information from the SCIS (Switching Cost Information System) model developed by Bellcore. There is also information in the SNC (Switched Network Calculator) model of BellSouth that is derived from the SCIS. The SCIS is a model that Bellcore considers to be proprietary, and BellSouth is contractually bound by an agreement with Bellcore to treat it as such. This model incorporates information given to Bellcore by switch vendors, as well as programming algorithms developed by Bellcore to translate the switch vendor information into cost profiles for various applications. This computer model has been developed by Bellcore over the course of more than a decade at a cost of tens of millions of dollars. If any of this information were made publicly available, the value of Bellcore's model and the related services it provides would decrease dramatically. This information is valuable, it is used by BellSouth in conducting its business and BellSouth strives to keep it secret. Therefore, such information is a trade secret which should be classified as proprietary, confidential business information pursuant to Section 364.183, Florida Statutes, and is exempt from the Open Records Act.

This study is entitled: "BellSouth Price Sensitivity Study: Area Plus, Complete Choice, Vertical Services"

All information on every page is proprietary and of immediate value to new competing local exchange companies that could offer vertical service and flat rate intraLATA calling packages to current BellSouth residential customers. The presentation format of the material requires that the title of each page describes the key material on that page. The presentation includes strategic pricing issues raised by the results of the market research, the percent of residential customers with various services, the percent of customers likely to take each service across a range of different prices, price elasticities by service, and conclusions on the revenue impacts across services of various package pricing strategies. The bulk of the material consists of graphs or tables for many services of the percent of residence customers who would take each service across a range of plausible prices as well as reporting a price elasticity for each service. Disclosing the slope of the plotted lines without the scale would reveal price elasticity information for these services. Disclosing just the scale of each of these graphs and tables could give potential competitors information on the share of customers with each of these services. Disclosing which vertical services were included and not included in the study would give potential competitors information on the relative importance of those services in the market place. The analysis also displayed total revenue analyses across multiple services of different pricing scenarios, the disclosure of which would provide valuable information on BellSouth pricing and marketing strategies to potential competitors. The analysis also compared the price sensitivity of BellSouth residential customers by state. The study is also very recent (November 1997).
