- J) DOCKET NO. 981242-EI - Application of Florida Power & Light Company (FPL) for approval to issue, sell and/or exchange any combination of long-term debt and equity securities and/or to assume liabilities or obligations as guarantor, endorser or surety in an aggregate amount not to exceed \$1.6 billion during the twelve months ending December 31, 1999. FPL also seeks authority to enter into forward refunding or forward swap contracts during calendar year 1999, and in conjunction with these forward contracts, FPL seeks authority to issue and sell up to \$151 million of securities through December 31, 2002. In addition, FPL seeks authority to issue and sell short-term securities during the calendar years 1999 and 2000 in an amount or amounts such that the aggregate principal amount of short-term securities outstanding at the time of the sale will not exceed 25% of FPL's gross revenues during the preceding twelve months of operation.
- K) DOCKET NO. 981268-EI - Application of Florida Power Corporation to issue and sell securities during the twelve months ending December 31, 1999. Florida Power Corporation requests authorization to issue any combination of additional equity securities and long-term debt securities and obligations, consisting of (i) up to \$400 million outstanding at any time of commercial paper backed by, or borrowings under, the Company's long-term credit agreements, and (ii) \$910 million of any combination of equity securities and other long-term debt securities and obligations. In addition, the Company proposes to issue, sell and have outstanding at any given time during 1999 short-term unsecured borrowings and debt obligations, including commercial paper classified as short-term for accounting purposes, in an aggregate amount not in excess of \$500 million.
- L) DOCKET NO. 981213-GU - Application of Chesapeake Utilities Corporation for authority to issue and sell up to 5,000,000 shares of common stock, and \$70,000,000 of secured and unsecured debt. The maximum amount of short term obligations outstanding at any one time will not exceed \$40,000,000 for the fiscal year 1999.

Recommendation: That the Commission approve the action requested in the dockets referenced above and close these dockets, with the exception of Dockets Nos. 981242-EI, 981268-EI, and 981213-GU, which are to remain open until April 15, 2000, for monitoring purposes.
