UniDial Holdings, Inc. ("UniDial") and Metracom Corporation ("Metracom")(together the "Parties"), hereby notify the Commission that the Parties have consummated the abovecaptioned transaction. As set forth at length in the Parties' letter application filed on May 26, 1998 in the captioned docket and approved by the Commission on June 30, 1998, for various financial reasons. UniDial established Metracom as a wholly-owned subsidiary through a forward subsidiary merger. Specifically, Metracom was merged with and into a wholly owned subsidiary of UniDial which immediately changed its name to Metracom after the transaction.

For corporate reasons related to the transaction, the Parties chose to employ a limited liability company instead of a corporation as the acquisition subsidiary.
