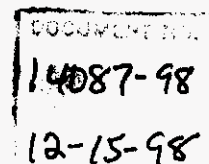
NOTICE OF HEARING

A hearing will be held in this case at the Dade County Courthouse, 73 West Flagler Street, Miami, Florida, on March 30-31, 1999, beginning at 9:00 a.m., or as soon thereafter as can be heard. Report to Room 1600 for room assignment. Two days have been set aside for this hearing. Continuances will be granted only by order of the Administrative Law Judge for good cause shown.

ISSUES: Whether there was meter tampering at Petitioner's residence and if so, whether Respondent's calculation of the back-billed amount and investigative costs is correct.


AUTHORITY: Section 120.57(1), Florida Statutes, and Chapter 28-106, Parts I and II, Florida Administrative Code.

The parties shall arrange to have all witnesses and evidence present at the time and place of hearing. Subpoenas will be issued by the Administrative Law Judge upon request of the



parties. All parties have the right to present oral argument and to cross-examine opposing witnesses. All parties have the right to be represented by counsel or other qualified representative, in accordance with Rule 28-106.106, Florida Administrative Code. Failure to appear at this hearing shall be grounds for entry of an order of dismissal or recommended order of dismissal, as appropriate.
