I have attached hereto a copy of a preliminary draft of an engineering analysis of the K.W. Resort Utilities wastewater treatment facility prepared by the Utility's outside consulting engineers. I believe this should supply substantial information along the lines of that requested in your letter dated December 2, 1998 and the letter from the Department of Community Affairs that preceded it dated November 20, 1998. Please review the preliminary report and let me know if you have any further questions.

Hopefully, this answers all of the staff and the DCA's questions as raised and we can move forward quickly with the approval. As I have noted in my previous letter, time is of the essence in getting final approval from the Commission so that the Utility can move forward with providing service to those in immediate need of it and also to take advantage of ongoing roadwork which will substantially reduce the cost of installing collection lines if those mains can be put in while the roads are under construction.
