
To Whom It May Concern:

I am writing on behalf of NEXTLINK Florida, Inc. (NEXTLINK), relative to the Docket referred to above. Based upon information that I obtained from Ms. Paula Isler of the Public Service Commission (PSC), the PSC scheduled the item on its docket for consideration for failure to pay the regulatory assessment fee of \$68.00 that was due on January 30, 1998. As you may not be aware, NEXTLINK acquired its telecommunications license from Chadwick Telecommunications Corp. on June 13, 1998, nearly six months after the deadline for payment by Chadwick. At the date of the license transfer, NEXTLINK was unaware of the pending fee due to the PSC by Chadwick. To resolve this matter amicably, and without further proceedings, NEXTLINK is enclosing a check in the amount of \$68.00 payable to the PSC for regulatory fees owed through January 30, 1998, on Interexchange Telecommunication Certificate No. 3505
