Dear Mr. Stanfield:

I write to confirm our telephone conversation of this morning, concerning the time afforded the Commission to rule on Florida Power Corporation's request for a waiver of Rule 25-22.082(2), Florida Administration Code.

The petition was filed on October 20, 1998. Section 120.542(8), Florida Statutes, requires an agency to "grant or deny a petition for variance or waiver within 90 days after receipt of the original petition." In the instant case, the 90 days runs on January 18, 1999. January 18, 1999, is Martin Luther King day, a legal holiday designated in Section 110.117, Florida Statutes.

Rule 28-106.103, Florida Administrative Code (The Uniform Rules of Procedure) provides that when the last day of a time period is a legal holiday, "the period shall run until the next day which is not a Saturday, Sunday or legal holiday." Thus, the time period for a Commission decision does not run until January 19, 1999.
