

Thank you for your letter regarding the rate case which is being processed for Dixie Groves Estates, Inc. (Dixie Groves or utility). As we explained at the customer meeting in New Port Richey on December 2nd, the staff assisted rate case process was developed by the Florida Legislature to assist customers of small water and wastewater customers such as Dixie Groves. Instead of the utility having to retain outside accountants and engineers to process a rate case, Florida Public Service Commission (PSC) staff does the work and normally saves customers thousands of dollars in costs which would have been passed on to customers of the utility through rates.

Although the amount of the increase for this rate case may seem excessive, this utility has not had a rate case in over 18 years. If Dixie Groves had filed for a Commission approved price index rate increase each year since 1980, its rates would have increased over 100%, more than the increase which staff is presently proposing, and it likely would not have had to file for the present rate case. The price index, which is established by statute on a yearly basis, is an inflationary tool designed to keep utilities from filing for full rate cases every few years.

As you know, Mr. Gerald Edwards, the staff engineer assigned to this case, made onsite visits to your home and Ms. David's home on December 3rd to investigate water quality problems, but found no evidence of abnormal water quality at the time of the visit. If further water quality problems arise, please don't hesitate to contact Mr. Edwards.

Staff's final recommendation will be filed January 7, 1999 for consideration by Commissioners at the January 19, 1999 Agenda Conference in Tallahassee. You, as well as all customers of the utility, are welcome to attend the Agenda Conference and relay your concerns to the Commissioners. Once the Commissioners vote on staff's recommendation at Agenda, a Proposed Agency Action (PAA) Order will be prepared and issued within 20 days. Any substantially affected party may

Dear Creighton and Ruth Broeker:

Thank you for your letter received by the Division of Water and Wastewater on November 16, 1998 regarding the rate case which is being processed for Dixie Groves Estates, Inc. (Dixie Groves or utility). The staff assisted rate case process was developed by the Florida Legislature to assist customers of small water and wastewater utilities such as Dixie Groves. Instead of the utility having to retain outside accountants and engineers to process a rate case, Florida Public Service Commission (PSC) staff does the work and normally saves customers thousands of dollars in costs which would have been passed on to customers of the utility through rates.

The rates and percentage increases contained in the "Staff Report" and "Notice to Customers" are preliminary pending the outcome of the customer meetings, updated costs, and further staff investigation. As you may know, a customer meeting has been scheduled for 6:00 pm on December 2, 1998 in the Commission Chambers of the City of New Port Richey located at 5919 Main Street. The purpose of this meeting is to give customers and other interested persons an opportunity to offer comments to the PSC staff regarding the quality of service the utility provides, the proposed rate increase, and to ask questions and comment on staff's preliminary rates. A staff engineer will investigate the service outages you mentioned in your letter to determine if they were planned or emergency outages, and if they were planned, if proper notice was given to the customers.

The final recommendation to the Commission is scheduled to be filed January 7, 1999 for consideration by Commissioners at the January 19, 1999 Agenda Conference. You are welcome to attend the Agenda Conference and relay your concerns to the Commissioners. Once the Commissioners vote on staff's recommendation at Agenda, a Proposed Agency Action (PAA) Order will be prepared and issued within 20 days. Any substantially affected party may protest this PAA Order within a 21 day protest period after the Order is issued. If there is no protest of the PAA Order, the Order becomes final.
